Affiliation Fees for the 2021/2022 Year

The Executive recognised the impact Covid-19 has had on clubs over the last 18 months and it was agreed at the AGM that our Affiliation and first Delegate Registration Fees, which normally are due by the 1st August at a cost of \$300, will this year be waived, there will also be no invoices emailed out.

Please note

The Executive will assume a club has chosen to reaffiliate unless we have heard otherwise by the 1st August, 2021.

Annual memberships fee will remain in place, due in one month after the club's balance date.

2021 AGM Report

The AGM Minutes and the 2021 Rulebooks are currently being edited and completed. All Rule book changes are <u>effective immediately</u> and once completed, they will be available for download on the Association website.

Please refer back to your club delegate/s for a full report and once the AGM Minutes are on the Association website, they will also have the full report.

Overview:

All Remits passed, a couple were amended.

Any alterations of Rule Book A can now be made at a Special Meeting if one is required rather than having to wait for the Annual General Meeting every year.

Assessments are now required to be held within the year preceding the National Championship.

Any Couple/Triples who have already achieved National Qualifying Level points in an assessment can on request and with the discretion of the Executive, be able to change to another section with the same or less National Qualifying Level points.

Remits 3 - 9 were focused on Judging guidelines, so because they are related to Judges and Judging criteria, they will be communicated to all Judges through the Head Judge in due course. Full explanations and reasonings will be available in the AGM minutes, once they have been loaded up onto the Association website.

We now require a Register of Compliance from Judges, which will be held and maintained by both the Association Secretary and Head Judge. The Head Judge is responsible for ensuring the Secretary has been notified of judges compliance-related activity.

Judges are responsible for ensuring their contact details are true and correct when given to the Association Secretary who will update the list on the Association website accordingly.

Other items of Note

Discussion around making Friday night of Nationals more fun, having some kind of fun dance competition would be nice. Agreed that this is at the discretion of the host club.

Zoom assessments were discussed with views both for and against. The Head Judge advised that she would look at this closer and report back.

The Executive Committee would like to thank all Delegates for their willing participation at the 2021 Annual General Meeting that was held via Zoom and look forward to working with you all this coming year.
