As you all are aware this year's Junior and Senior Nationals were cancelled due to Covid-19 pandemic. We are living in unprecedented times and it was a hard decision to make but one that the Executive felt was necessary.

The Executive thanks the 2020 host clubs for graciously accepting that this would happen and they have been offered the 2022 National hostings as alternatives.

#### 2020 AGM Report

The Executive Committee thanks all delegates at the 2020 Annual General Meeting; which was held for the first time via Zoom Conference call.

Please refer to your delegate/s for a full report. The AGM Minutes and the 2020 Rulebooks are currently being completed and edited. All Rule Book changes are effective immediately. Once completed, the Rule Book can be downloaded from the Association website.

#### Please note:

The Executive will circulate a survey that will gauge how the delegates felt about how the 2020 AGM went via Zoom Conference call. This will help the Executive to decide whether this is a viable option going forward when looking to future NZARRA AGM's.

#### Rule changes that were passed at the AGM

- Junior age criteria is now 5 10 years old.
- Intermediate age criteria is now 11 13 years old.
- Any couple/triple having achieved National Qualifying assessment may at the discretion of the Executive be allowed to change sections that have equivalent or lower National Qualifying points without having to be reassessed. This does not include Restricted sections.
- Cheerleading will have music <u>without</u> lyrics and have 4 minutes for getting on and off the floor within their routine.

- The Executive has the right if deemed necessary to remove someone for a specified time if that
  person or persons has been verbally and/or physically abusive towards anyone else attending
  the event.
- Judges section was tidied up and made clearer.
- 'Reasonable' Insurance for travel costs will be met by the Association going forward.
- Cheerleading teams will receive 1 medal for each team that places, to keep costs down and align with the Novelty section.
- Novice Same Sex couples will be allowed to enter in the Novice section which is held on the Saturday of national competition but will mean they are no longer able to compete in the Same Sex section on Sunday.

#### **General Business Discussion**

- Judges sheets options will be looked at to have a cheaper, easier and environmentally friendly way for clubs to receive these.
- The council discussed assessments for this year being carried over to the following Nationals. Agreed that this would not happen due to Nationals 2020 not being rolled over. So it is a new year, as per normal.
- Discussion around the next AGM being brought forward due to flight arrangements being postponed due to covid 19 this year. Was agreed that clubs will be still able to book their flights within the next year which meant no AGM change is necessary.
- Lifetime Achievement award was put forward. The Council decided it would be something too big and complicated to achieve, however nice it would be.
- Kapi Mana wanted to discuss whether other clubs had public liability insurance. Most clubs do not.
- The cost of National Dvds was discussed and whether there are other viable options, keeping up with the times..Council agreed we do need to look at other options going forward.
- The council discussed allowing an extension or dispensation for those juniors whose last
  nationals were going to be this year and had unfortunately missed out. The council were
  sympathetic but as 2021 is not a roll over and is a new year, and are also requiring new
  assessments so It was deemed unfortunate but not a viable option that could be considered.
  The Association would have to amend rules in the Rule Book, look into how we would
  accommodate those dancers at nationals and whether it was fair to other Juniors who are
  rightfully there already.
- Discussion around the cost of mileage when being reimbursed for a Nationals competition. It was advised that the cost is based on the RA Rating and when clubs reimburse their judges for local competition using the Rule book is a guideline not exact costing.
- Asked if the Association can minimise the amount of songs being put forward a year as some songs are just same-same or not worth listening to. Would like to get better quality songs coming through. Suggestion was 10 songs per club per year. Not all in agreement and something to look at at a later date. Current songs out for circulation are being put off till next year for decision.
- Question on how other clubs are handling the COVID-19 Pandemic and when will clubs look at opening back up. The council agreed that it's not up to the Association to decide but when the individual clubs deem they are ready to. However it is important to use the government recommendations when they do go back to dancing.

#### Other Items to Note

Clubs are urged to confirm their accommodation and advise the hosts clubs of their club contact person for the appropriate Nationals.

Once your club's team manager is appointed, please provide their contact details to the Association Secretary.

Please direct your club members to the Association website, so they are up to date with any Host Club information going forward.
